NRW carried out a routine inspection of St Davids Recycling Centre (EPR-FP3698FM) on 23/01/2020. NRW Waste Regulation Officers Michael Edwards and James Kinkead attended, and were welcomed onsite by Mr Colin Reed. This was an unannounced inspection.

Waste Storage.

All waste and recycling areas were tidy and the containers were in good condition. All waste appeared well segregated and signage was clear and appropriate. No containers or storage areas appeared to be overfilled or contaminated.

Site staff explained that they were unaware of any current provision for storage of quarantine items if they are identified on site. **Section 4.4.4** of the permit states that

'Incompatible wastes which are likely, in combination with each other or with other material at the facility, to give rise to pollution of the environment or harm to human health outside the site, shall be clearly identified and kept physically separate in designated areas'.

Action: PCC may wish to consider assigning a defined area on site for storage of quarantine items (for example asbestos) that may be deposited on site. Storage of these wastes must be in line with the conditions of the permit.

Site infrastructure.

The site is in good general condition. No breaks in the impermeable surface or pooling of water was noticed. Site was tidy and there was no loose material noticed within or near the site boundary.

Other observations.

A short copy of the amended site Permit including a list of waste codes was available for inspection in the site office. **Action:** Please ensure up to date copies of the full site Permit and Environmental Management System (EMS) are provided and stored in the site office for staff to consult if necessary. Please also provide NRW with an up-to-date copy of the EMS and continuing competency document for the site Technical Competent Manager (TCM).

A moderate amount of green waste was present on site (see images 1 to 3). NRW would like to remind the site that according to table 1, section b, part ii of EPR-FP3698FM:

'Degradable wastes shall only be stored on site for a maximum of 72 hours'.
