A routine site inspection was undertaken on Monday 2nd December 2019 by Natural Resources Wales Officers, David Morgan and Cathy Lloyd.

No non-compliances were recorded during the inspection and the following observations were made.

Site Layout & Infrastructure

The layout of the site has changed considerably over the last 2 - 3 years. The site was accessed on foot. Please ensure traffic management procedures are well maintained. Due to size of the site, and large number of traffic movements, I will suggest that all future inspections are conducted with a member of staff present.

Site infrastructure appeared to be in a very good condition. The impermeable site surface where waste is delivered, sorted and treated appeared to be free from damage thus suggesting it is well maintained. There was no pooling of water or build-up of rainwater run-off in the yard.

Plot 2

The area of the site referred to as 'Plot 2' has been under development for some time. At this current time, this area does not benefit from any Waste Exemption and is not within the permit boundary. During the inspection it was noted that a small number of waste vehicle tyres were stored in this area. Please ensure these tyres are removed from area. Alternatively, you may wish to pursue the registration of a waste exemption and/or permit variation.

There were also a number of cars in this area. It was suggested that these vehicles were ready for re-sale and were not waste. At the time of the visit, there was no evidence to suggest that these vehicles were waste as all appeared to be in a relatively good condition. Please ensure pollution prevention measures are taken in the area as this area is unmade ground.

As Plot 2 is developed please ensure all of the correct authorisations are in place for any potential landscaping works where waste material is used in building/landscaping. It is acknowledged that baled tyres have previously been used (under Waste Exemption) to reinforce the wall/acoustic attenuation bund. You must keep a record of wall waste material used in this location. This includes soil/stone used under a U1 Waste Exemption.

Summary

Despite the changes to the site layout, the high levels of traffic and waste movements on site, there were no non-compliances recorded during the inspection.

You must ensure the Environment Management System is kept up to date to reflect changes to site infrastructure/layout.
