I met with Alan Llewellyn at the site in Clydach. Since my last inspection Terri Shaw has left the employment of Swansea City Council. I requested that Alan forward me the provisions to cover the Technically Competent Manager for the asbestos store. I received this on the 9th of October. Chris Fender and Mathew Perkins who both work at the Bailing Plant based in Llansamlet will cover this role for the permit. They both satisfy the requirements of the competency scheme set by WAMITAB.

Alan and I inspected the asbestos compound which is rarely used. We discussed the option of surrender. I have supplied Alan with the links to the application form.

The impermeable pavement does require some upgrading. This was discussed during my last inspection. The site will be scored again for this non compliance. If the infrastructure isn't improved by the next inspection a warning notice will be served.
