NRW were provided with Part A Schedule 5 Notifications by Knauf on 18th July 2019 and 7th August 2019 in respect of measured exceedances of the particulate emission limit at A0. These reported values for particulates of 38.4mg/m³ for 17th May 2019 and 37.9mg/m³ for 24th July 2019, respectively, against a permit emission limit value of 35mg/m³.

NRW received the follow up combined Part A and Part B Notification on 23rd December 2019 following completion of Knauf's consequent investigation and remediation work.

Whilst Permit Condition 3.1.2 states 'The limits given in schedule 3 shall not be exceeded', in this instance the reported particulate values are within a 30% uncertainty allowance. On this basis a permit non-compliance has therefore not been recorded.

Please ensure that in the event of any future need to submit a Schedule 5 Notification the proforma attached to the current version of the permit is used - this correctly refers to a Schedule 5 Notification, some older versions of the permit included a template that is entitled Schedule 6.
