NRW were informed by Email on 17th December 2019 that it was necessary for Knauf Insulation to shut down the EP unit in order to complete essential preventative maintenance work. This would take place over the period Tuesday 17th December at 1500h until Thursday 19th December at 1500h.

NRW accept that this course of action is necessary and that it is not possible to shut down the furnaces at the same time as they would be damaged.

Knauf Insulation must take all possible measures to minimise emissions during this period.

NRW must be informed of any complaints received during the shut down period and when normal EP operation is re-established.
