Introductory note

This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This variation adds a standard rules Medium Combustion Plant (MCP) within the current installation boundary, under Standard Rules permit SR2018 No 7 'New, Low Risk, Stationary Medium Combustion Plant 1 and < 20MWth (in operation after 20/12/2018)'. The MCP is a 2.7 MWth (rated thermal input) natural gas fuelled Combined Heat and Power (CHP) engine. The burning of natural gas in the CHP plant will provide a mechanism for the creamery to produce its own electricity, and by products such as steam and low temperature hot water will also reduce the gas demand required for steam generation in the creamery process. There will be a stack from the CHP to discharge air emissions. The primary pollutant of concern is NO_x which is controlled by an emission limit value in the standard rule set. There are no emissions to water or land. It is classed as an MCP and an excluded Specified Generator (SG). The SG is excluded as it is part of an Industrial Emissions Directive installation under Chapter II. All of the standard rule criteria for SR2018 No 7 have been met in the application.
