The installation continues to comply with the low impact criteria.

Production volumes have decreased this year, but waste generation and water and electricity use have all increased when corrected for production volumes. The largest increase was in waste production (~40%), the smallest in electricity use (~8%). No fuel oil was used in 2019.

It is encouraging to see that Alembic have replaced their cooling towers with an adiabatic system which should help to reduce their water consumption.

The report is accepted.
