This was an unannounced visit and an opportunity to get an introduction and familiarisation visit to understand the daily running of the site.

Weather conditions throughout the visit was heavy rain and strong winds poor visibility due to the rain.

The highway outside the site was free from any mud and debris.

The yard had a few debris and muddy puddles due to the storm like weather. Staff were out on site working and keeping the site tidy.

This was a very quick visit due to the poor weather conditions. The site was quiet, and no waste material was being deposited. Some of the bays were empty and other skips had waste stored. Some farm plastic wrap waste was overflowing from the shed (see pic).

Overall the appearance of the site was tidy and well organised with the waste appropriately stored.
