This was an unannounced visit and an opportunity to get an introduction and familiarisation visit to understand the daily running of the site.

Vincent Thomas TCM, accompanied us throughout the inspection.

10th December 2019 time 1:45 pm

Weather conditions throughout the visit was damp, drizzle with some burst of rain, slight wind.

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy and had the appropriate signage. Site security was good with fence and lockable gate including site CCTV.

Site was operational during the inspection with members of the public on site with waste being actively segregated and placed in the appropriate skips.

The compound is well organised with textiles now being stored indoors due to the textiles being targeted by thieves. Paints are rehomed if appropriate. Electronics stored in a secure container and WEEE products stored ready of pick up. All other waste also stored and segregated very well.

Items that are in good condition are inspected and will be sent to the onsite charity shop instead of being sent to the skip which in turn helps the community, charity and environment and is an excellent initiative.

No issues were noted relating to noise, odour, litter or pests.

The site Diary was inspected and was held in a locked office. Diary was up to date and detailed everything in and out of the yards including forklift check and other checks carried out.

Some waste transfer notes were viewed including their input onto the data base. We also had sight of their onsite check folders. Current certificate on file has expired in September, we would welcome a copy of the new certificate.
