Present was Mr Kevin and Cai Humphreys.

Mr Kevin Humphreys accompanied the inspecting officers throughout the inspection. Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

Site was operational during the inspection with waste being processed through the trommel and picking line. waste was being actively segregated and sorted by the staff and the line had been slowed down in order to show us how the process. No issues were noted relating to noise, odour, litter or pests throughout the inspection

The compound and inside the transfer building was tidy and well organised with processed wastes stored in the appropriate areas. Overall the appearance of the site was tidy and well organised with lots of space available within the central area of the site for movements of waste to take place.

The outside at the back of the compound was also neat and tidy and had a few recycling bales ready for transporting. No waste material was observed outside the permitted area.

At the end of the visit we viewed the sites internal waste returns database and a selection of paperwork including site inspection checklists and completed waste transfer notes.
