This prearranged site inspection was carried out on Friday 22nd November 2019 by Natural Resources Wales officer Donna Muirhead (Industry & Waste Regulation Officer),

Phil Harper (Industry & Waste Regulation Officer),

Dan Grant (Hazardous Waste Regulation Officer) and

Ross Briscoe Senior Advisor (Waste Policy).

Mr Richard Hughes and the site supervisor accompanied the inspecting officers throughout the inspection.

Weather conditions throughout the visit was dry bright and no wind.

The compound and inside the transfer building was tidy and well organised with processed waste stored in the appropriate areas. The machines were not in operation at the time of the inspection due to a breakdown, with the mechanic on site fixing the issue. The bays along the Northern boundary of site, included glass, scrap metal, bulky waste, green waste, plastics and road sweepings.

The outside at the back of the compound was also neat and tidy with no debris and no waste material was observed outside the permitted area.

The yard was clean and tidy and with lots of space available within the central area of the site for movements of waste to take place where a tractor was loading a wagon.

No issues were noted relating to noise, odour, litter or pests throughout the inspection and the boundary fence was intact.

Walking down towards the weighbridge, gas bottles were appropriately stored in lockable containers in a safe area. The weighbridge areas were clean and tidy no waste stored here and no issues.

Bin wagons were queuing up to deposit the roadside and commercial waste to the residual and trade waste building and a lorry was being loaded whilst we were inspecting. Inside the shed there were two holding areas which had waste stored accurately. No issues were noted here relating to noise, odour, litter or pests throughout the inspection.

The civic amenity site was busy at time of inspection. This area was tidy and organised with all waste stored in designated containers. Overall the appearance of the site was tidy and well organised and managed.

No paperwork was viewed at this visit.
