B3 - Sit drainage engineering (Clean and Foul).

During the inspection, we noted that some of the drainage channels on site were filled with silt which allowed vegetation to grow in some places, this issue was highlighted during the previous inspection and resulted in a breach of permit. Under **condition 2.1.2** of the environmental permit, the engineered site containment and drainage systems shall be inspected, validated and maintained...!.

This has once again been scored as a **category 3 breach** of permit **condition 2.1.2** as the amount of silt found in the channel and the growth of vegetation is evidence that no maintenance of the drainage system has been undertaken in some time.

Action - ensure that routine maintenance is undertaken to remove and reduce the amount of build up in the sites drainage channels.

B4 - Containment of stored materials

Wastes were stored in skips on impermeable pavement as required by **condition 1.1.1 a**, referring to **table 1.1** of the permit.

D1 - Site security

Under **condition 3.2.1** of the permit the site is required to operate to the site security system standards in **table 3.2**. During the inspection the site was kept closed and locked when unattended as required by **part C of table 3.2** and no signs of damage or defects were found on the fencing.

C4 - Storage, handling, labelling and segregation

Under **part C of table 4.4** of the environmental permit the site is required to identify all wastes that are stored on site. This was done well with clearly marked signposts above the waste skips.

C3 - Materials acceptance

No nonpermitted wastes were identified on site.
