Compliance report as a result of incident 20/07/19 WIRS report 1904800 SAP reference: 95035965 - discharge of crude sewage to the River Llynfi due to partial blockage in the downstream sewer network, not in storm conditions. Please note, new EPR permit issued for this asset on 21/10/2019 including Event Duration Monitoring requirements, this incident occurred when previous permit dated: 27.04.97 was in place, therefore compliance has been assessed against the original permit prior to the variation being issued.

The discharge was in contravention of permit condition 1 "The discharge shall consist only of storm sewage." and has been assessed as a Category 3 non-compliance.

A 'no impact' claim was submitted to NRW on 01/08/2019 following the incident, officers did not agree that the incident constituted 'an event' and the incident was categorised as 'low level' to water. In the no impact claim report submitted, the following statements were made:

"Network has been cleaned and CCTV was completed that identified no further restrictions of defects. Asset maintenance visits have now been increased to two weekly visits.

CSO asset is currently on IM with proposed solutions -

1. Replace existing powered 10mm mechanically raked bar screen with a new powered 10mm mechanically raked bar screen;
2. Installation a flow control device to control pass forward flows;
3. Replace existing 150mm diameter continuation sewer with a 300mm diameter sewer;
4. Replace 2 manholes;
5. Construct a new 300mm diameter sewer to remove a 90 degree bend downstream of the CSO;
6. Improve access road to ensure suitable for heavy maintenance vehicles."
