This was a pre-arranged site visit with members of the 'People and Places' Team responsible for the formulation of Natural Resources Wales' Area Statements; the purpose of the visit was to give the team an insight into the waste industry and NRW's role in regulating it.

The visit was arranged with Steve Rymill (Compliance Manager) who, along with Danny Flood (TCM) and Bernie Carr (H&S Manager) met with NRW officers in the ASH Wrexham office on Redwither Road. Following a brief background into the site and ASH's role in the industry a site tour was carried out showing the sorting shed, wood recycling areas, and biomass boilers (regulated by Wrexham Borough Council). Steve, Danny and Bernie were on hand throughout the visit to answer any site-specific and industry specific questions posed.

As this was not a regular site inspection site operations were not assessed during the visit, should there have been any potential significant breaches observed these would have been brought to your attention.

No breaches of permit/EMS/FPMP conditions were observed during the visit; the site was clean and tidy with sweepers and machinery constantly cleaning the yard. Waste piles were small and no non-compliant wastes were stored on site.

I would like to thank Steve, Danny and Bernie for their assistance, they were very helpful and the People and Places Team thought that the visit was very interesting and worthwhile for their work in creating the NRW Area Statements.
