Requirements - Condition 2.10.1 requires the operator to maintain and implement a programme that ensures emission points are monitored under an appropriate range of operating conditions, to specified methods and frequencies, and that monitoring results are assessed. Condition 4.1.2 requires timely submission of monitoring reports in an agreed format.

Conditions 4.1.2, 4.1.3, 4.1.4 and 4.1.5 require submission of annual reports on performance indicators, environment management system targets and a fugitive emissions review by 31st January each year.

Findings - The monitoring reports for emissions to air, water usage, performance indicators, waste and energy usage and the annual reports for performance, EMS improvement targets and fugitive emissions review were all received on 08/01/2020.

Emissions monitoring was carried out on 05/05/2019. All monitored parameters were within the relevant emission limit values specified in the permit.
