Celsa Manufacturing UK Ltd. have notified NRW of the following exceedances for CO through Schedule 5 notifications for the period October to December inclusive 2019.

Scoring has been suspended on the basis that there is no ongoing justification to include a CO limit in the permit (subject to a satisfactory air quality assessment) and this will then be removed as part of the next variation. See further comments below.

In accordance with current NRW policy, only the first exceedance of an emission limit value in the reporting quarterly period is categorised as a non-compliance. No further non-compliances for the same species are recorded in the quarterly period. However, as noted above all scores for CO exceedances have been suspended pending a permit variation. Of particular note is that the EC BREF for Iron and Steel Making does not include an emission limit value for CO for Electric Arc Furnaces. Therefore, in the absence of any specific local air quality issues there is no ongoing justification for retention of a CO limit.
