MRF

It was confirmed that the MRF building was empty of waste, and was being used as a store, the machinery was non-operational.

Transfer Station

The transfer station was being used for the deposit and onward movement of waste to the landfill. At the time of the inspection the waste was being stored within the bays on the impermeable surface.



Waste returns

As previously discussed with NRW officers, the waste being accepted onto the permitted area in the transfer station is being captured in the quarterly waste returns. It is noted that this has been logged by NRW as received for Q1 and Q3 2019. Q2 (Apr – June) 2019 is not showing as having been received.

ACTION: Submit Q2 2019 waste returns submission along with Q4 by the end of January 2020.
