Many thanks for your time during the first inspection at Glangwden Poultry Farm on the 18th December 2019. The inspection was conducted during turn around, (no birds).

The inspection found that you were largely compliant with your permit. As discussed on site please amend/provide the following -

1.Raw materials (see page 5 of assessment form) No. 8, you have provided a list of your raw materials, this list must also be appended to the accident management plan (No 6).

2.Spreading on own land (No.16) - Soil nutrient status - there was no record of any recent manure analysis. Please ensure that if manure from the site is spread on land owned by the operator (rather than export), manure must be analysed twice yearly, or once per production cycle where that cycle exceeds six months. Analysis should include: total nitrogen, available nitrogen and total phosphorus. Records of nutrient sampling and reviews must be maintained. Please ensure analysis is undertaken. Please send a copy of current sampling results to NRW by the 2nd March 2020.

3.Site Plan (No. 23) - Permit site layout plan you currently have is needs to be updated - The site plan layout should be an accurate representation of the site (including clean and dirty water drains and storage). It should show external features such as roads. All site buildings and structures should be accurately shown and the installation boundary should be clearly marked. A very good plan should be to scale with north marked. Please send a copy of current sampling results to NRW by the 2nd March 2020.

When we discussed chemicals, it became apparent that other than the disinfectant currently on site, chemicals are rarely stored at the site. Please ensure when chemicals are stored on site that they are stored with an impermeable containment facility with no less than 100% containment capacity.

We discussed collision barriers for feed silos, this may be achieved by the provision of kerbs, markers or barriers. A kerb was identified between the sheds, I noted that there were two more silos along side the top shed, I didn't review this area but would suggest that provisions are put in place for silos if not already in situ.
