Many thanks for your time during the inspection on 17th October 2019. The inspection found that Upper Esgair Poultry Unit is compliant with the permit conditions.

As discussed, this is the second clear inspection for Upper Esgair Poultry Unit, the installation is eligible to join the NRW Pig and Poultry Assurance Scheme. Joining the scheme would mean the chosen certification Body will carry out a visit every year the farm remains in the scheme and NRW will visit once every three years. Further information on the Pig & Poultry Assurance Scheme details have been sent in a separate email.

When reviewing the records, you explained the manure from the site is taken off site to another farm owned by yourselves. Records are to be kept showing where the exports have gone - name and address of the exported manure, quantities, dates, acreage. Thank you for the updated Manure Management Plan.

Advisory –

1. Raw Materials list - Please ensure the raw materials list (the list should identify the substance, storage provisions, annual usage, environmental fate and impact.) is appended to the accident management plan.
2. Disinfectants - Please ensure they are stored within an impermeable containment facility with no less than 100% containment capacity.
3. You explained the information on the notice boards had been taken down, please ensure the drainage plans, and emergency telephone number are reinstated on the notice board.
4. Please ensure the drain below the belt exiting the unit NRW visited is unblocked.

Please can you confirm the above points have been dealt with by the 25th November 2019.
