Natural Resources Wales' officers Julia Lloyd and Alistair Wilson attended on the 19th September 2019, this was an unannounced routine Water Resources Inspection.

Officers were not accompanied during the inspection.

It was dry and sunny at the time of the inspection, there was a good flow across the weir.

The following aspects of the permit were assessed -

Impoundment Licence MD/054/0001/005/V002, further conditions 9.5(i) - The tailrace screen.

The net previously installed has now been replaced with a metal structure.

9.5 (1) States - Before any water is abstracted under this licence, the licence holder shall ensure that all water leaving the tailrace and re-entering the River Vyrnwy at National Grid Ref: SJ12806 11716 Point Q on the map of licence shall be protected against the ingress of fish. The standard of protection shall be equivalent to that achieved by a 30mm aperture screen. As shown in picture.



At the time of our visit the screen was tilted and sitting just above the water. Please can you provide information on how the structure is managed, stating when and how it is used to protect against the ingress of fish.
