Many thanks for your time during the inspection on 14th October 2019. The inspection found that Upper Heath Poultry Unit is compliant with the permit conditions.

As discussed on site, this is the second clear inspection for Upper Heath Poultry Unit, the site is now eligible to join the NRW Pig and Poultry Assurance Scheme. As explained, joining the scheme would mean the chosen certification Body would carry out a visit every year the farm remains in the scheme and NRW will visit once every three years. Further information on the Pig & Poultry Assurance Scheme are detailed in a separate letter.

You identified that the site layout map shown on your permit does not document the correct location for the feed silos and the tank at the back of the sheds, you may wish to send an updated Map to NRW Permitting requesting an administrative variation to the permit.
