A site inspection was undertaken on Friday 17th January 2020. The purpose of the visit was to accompany Lee Jones of the Health & Safety Executive (HSE) as part of the HSE work program.

During our time on site the following observations were made:

Site Drainage

This inspection followed a period of very heavy rain. As a result, there was ponding of water in the waste reception area. This was present throughout the site.

To the rear of the site, there is the potential for surface water run-off to escape site. This run-off could potentially leave site onto a patch of grass that is next to a watercourse.

A recommendation is made that site surface drainage is reviewed. Surface water run-off could potentially pollute a nearby watercourse and measures must be taken to prevent this from occurring.

Waste Soils

There is a large amount of soils/earth and other inert wastes on site which appear to have been stored on site for a considerable amount of time.

A recommendation is made that a strategy be put in place to remove these wastes in order to prevent a potential breach of Landfill Regulations (e.g. waste stored for more than 3 years in-situ).

Waste Trial

It was noted that there still appeared to be some historical waste on site which is from the trial project to treat glass/waste fines. This is stored in the shed on site. Again, in order to prevent a breach of Landfill Regulations, this waste will need to be removed.

Future Inspection

No non-compliances were recorded during this inspection. However, we would like to conduct another inspection in the summer to focus on these issues, as this inspection primarily focussed on areas of compliance with Health & Safety in the Workplace. During future inspections we may wish to discuss quality protocol for aggregates and the Fire Prevention and Mitigation Plan for the site.
