Forms R1, Waste Disposal and Recovery 2019; WU1, Water Usage 2019: E1, Energy Usage 2019 and PI1, Performance Indicators 2019, were received on 28th January 2020.

All the forms are accepted.

R1, Waste Disposal and Recovery 2019

Total waste generated in 2019 was about 45% more per tonne of production (ptp) than in 2018, with almost four times more ptp being sent for disposal and nearly 18% more ptp being sent for recycling. There were several reasons for this increase, including increased production and the installation and commissioning of new plant. The plant did experience some quality issues during 2019.

Total hazardous waste generated increased by more than 40% ptp. Almost four times more waste ptp was sent for disposal but recycled material also increased by 12% ptp.

Total non-hazardous waste generated increased by more than 70% ptp, with waste sent for disposal being 27% less ptp and the amount sent for recycling increasing by 85% ptp. Even though the amount generated increased, the amount sent for recycling also increased significantly, which is a positive development.

WU1 Water Usage 2019

The total amount of water used was less than in 2018, equating to a reduction of more than 50% ptp.

This is a significant saving, especially as EnerSys increased production, experienced quality problems and installed new plant in 2019.

E1 Energy Usage 2019

The total amount of energy used and the resulting CO₂ were both less in 2019 than in 2018. The reduction in energy usage was more than 4% ptp and the amount of CO₂ released was more than 3% ptp less.

Performance Indicators 2019

The performance indicators for energy, waste and water have been discussed above.

Production increased by more than 5% compared with 2018.

The mass releases of lead were 13% lower ptp than in 2018.

The increases in the amount of waste generated are disappointing, but it is encouraging to note that the proportion sent for recycling has increased. EnerSys have provided a comprehensive explanation of the reasons for the increased waste, which are unlikely to be repeated next year.

The reductions in water and energy usage are very positive, especially since production volume increased in 2019. Lower lead emissions indicate that EnerSys are controlling their emissions efficiently.
