Waste Regulation Officers Sally Wakeford and James Kinkad of Natural Resources Wales (NRW) carried out a routine site inspection of Trojan Electronics 2018, Crymlyn Burrows, Swansea on 05/02/2020. Also attending from NRW was Ethan Banfield from the permitting department of NRW.

NRW officers were accompanied by Chris Williams during a tour of the site. This was an unannounced inspection to assess compliance with the permit held by 'Trojan Electronics 2018' (**EPR DB3993HD**). TE accept returned electrical items that have been classified as waste. These are all logged in to the internal management system individually. The items are assessed and where possible refurbished for re-sale (>80% are refurbished according to Chris Williams). Any parts that are stripped off WEEE items are logged and stored for re-use as refurbishment parts. Any remaining WEEE that cannot be refurbished or re-used is disposed of as WEEE and not mixed with any other waste stream.

Trojan accept Tesco electrical returns as waste on a consignment note. Examples of hazardous WEEE waste consignment notes going out of Trojan were provided for inspection (see **images 1 & 2**). All weights are recorded once the waste reaches its disposal destination. Up-to-date waste return documentation with appropriate EWC numbers has been provided to NRW from Trojan Electronics 2018.

A copy of the site permit was available on site. Trojan are currently updating their EMS as part of an ISO 14001 inspection - a working copy of this was presented in the office.
