Len Davies and Shaun Davies accompanied the NRW officers during the site visit. The consultant used by the operators to help them achieve compliance was unable to attend due to ill health.

The main purpose of the visit was to check compliance against the Regulation 36 notice that had been served on Rees metals Limited on the 22 March 2019 and which expired on the 31st October 2019. The notice required the hardstanding areas including the tracks through the site to be constructed and maintained in accordance with the permit and the removal of 'historic' scrap (Scrap that had been on site for more than 3 years) to be removed from site.

### Notice compliance:

It was good to see that large parts of the site had been cleared of the historic scrap and kept clear. A significant amount of material had been removed from the site. Whilst some historic scrap remained it was agreed that the terms of the notice had been complied with. Len Davies explained that they had been plagued with plant breakdowns and had struggled to process the scrap for removal off site. He then assured us that they would carry on working around the site and any remaining historic scrap would be removed.

Significant works have been undertaken improving the hardstanding and tracks through the site. It was a very wet day and few areas of standing water were observed. The works were not yet complete (again due to plant break downs) but enough had been undertaken to agree the terms of the notice had been satisfied. It remains to be seen how long the new surfaces will hold up and the operators were advised to implement their suggested changes to ways of working which were to include a treatment pad and management changes to reduce the slewing of machines.

It was concluded that the work that had been undertaken to improve the site was sufficient to comply with the requirements of the notice.

### General:

The bund under the shears had been cleared of waste (and issue and permit breach identified in the previous CAR). The bund was now able to do its job and retain any oil leaking from the shears. Please ensure this area is kept free from waste.
