Condition **1.1.1 (b)** states that activities shall be managed and operated: *by sufficient persons who are competent in respect to the responsibilities to be undertaken by them in connection to the operation of the activities.* Whilst condition **1.1.2** requires *records demonstrating compliance with condition 1.1.1 shall be maintained.*

Action – please submit evidence of the appointed Technically Competent Managers certification for NRW records.

Under condition **1.1.3** of the environmental permit, *any persons having duties of that are or may be affected by the matters set out in the licence shall have convenient access to a copy of it kept at or near the place where those duties are carried out.* During the inspection these documents were requested and were provided to the NRW officers.

Storage, handling, labelling and segregation.

All wastes on site were stored in accordance with condition **2.2.1** and **table 2.1.** with all wastes kept on an impermeable pavement with sealed drainage.

Materials acceptance

Under condition **2.2.1 (a)** wastes shall only be accepted if: *it is of a type and quantity listed in **schedule 2, table 2.2;** and Appendix D of the General management plan.*
