G1.Monitoring of emissions & environment

Thank you for sending the monitoring results received on the 5th February 2020 in relation to Schedule 3, Table 3.1 of your permit.

Reporting of emissions to air for CHP 1 and CHP2 for the period 07/09/18-11-09/19 - These results are complete.

Permit condition 3.1.2: The limits in Schedule 3 shall not be exceeded

CHP1 (Blue) is operating within the limits specified by the permit. However, the result for Oxides of Nitrogen (485mg/m³) is close to the limit of 500mg/l; with the measurement uncertainty (MU) of +/- 145mg/m³ this could potentially have breached the permitted limit - it is advised that CHP1 is assessed at the nearest opportunity to reduce the possibility of it breaching the above permit condition

CHP2 (Perkins) seems to be over the limit value for Oxides of Nitrogen but within the limits when taking the MU associated with the results; the limit specified by the permit is 500mg/m³ whereas the amount reported was 582mg/m³. The MU for Oxides of Nitrogen is +/- 175mg/m³; a result of 585mg/m³ is 'approaching the limit' specified in the permit, it is advised that CHP2 is also assessed at the nearest opportunity to reduce the possibility of it breaching the above permit condition.

ACTION: CHP1 & CHP2 to be assessed at the nearest opportunity to reduce the possibility of it breaching the above permit condition.
