Solvents Management Plan

The 2019 SMP was received on 31/01/2020. Solvent emissions as a percentage of solvent input has decreased due to variance in demand.

Quarterly emissions monitoring returns - Q3 and Q4 (Jul-Dec 2019)

Monitoring reports for all emission points and parameters required by condition 3.3.1 were monitored and the results were reported within the timescales required by condition 4.2.3 of the permit. All results were within the permitted emission limits.

Actions following OMA audit report CAR_NRW0035808

A response to the actions identified in the CAR form following the OMA audit on 15/08/2019 was received on 13/12/2019 providing responses to the three actions identified in that report. Improvements to sample point A6 and additional MCERTS awareness training have been put in place.
