This CAR form includes a review of the permit submissions for the Q4 period October - December 2019.

Emissions to water.

Monthly reports are submitted to NRW, as per permit condition 4.2.3, in relation to discharges to water. The October and December emissions reports did not highlight any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

During November there were two exceedances of the 5mg/l BOD emission limit. On 12/11/19 a result of 5.8mg/l was reported, and on 19/11/19 a result of 11.3mg/l was reported in the effluent treatment plant discharge. These two results have been queried with the analysing laboratory as all other determinands (pH, COD, NH3, SRP and SS) analysed within these samples were within permitted limits and normal range. Provide an update when advice is received from Aquabio.

Category 3 breach of permit condition 3.1.3, criteria E3 emissions to water.

Part A and B notification were received for these November breaches on 21/11/19 and 04/12/19 respectively as required by condition 4.3.2. The operator undertook an investigation which has not yet determined the cause of these anomalous results. Additional BOD testing kits have been purchased to allow validation of lab results, this is considered to be best practice and should improve the operators ability to provide an indication of effluent quality in real time.

Other monitoring and reporting.

November groundwater monitoring has been received from RUKHydro Ltd.

Annual performance indicator reports as required by condition 4.2.2 and tables S4.2 and S4.3 have not yet been received.
