The ESH Targets Overview for 2019 was received on 12th February 2020.

The report is accepted.

Reduction in energy use and CO₂ emissions were set at 3%. Energy use per 1000 parts fell by 14.9%, overall site energy use per month was 17.8% less and CO₂ emissions fell by 33.2%.

The target of reducing water use per 1000 parts was 3% and the actual saving was 20.7%.

One waste target was to increase the amount of recycled waste, as a percentage of total waste, to 95%. The actual increase was 0.5%, from 94 to 94.5%.

The other was to reduce the amount produced per 1000 parts by 3%. The actual reduction was 8.1%.

Risk assessments are being improved by developing a new system.

Continental exceeded most of the targets they set themselves, except for reducing coolant leaks and increasing the percentage of waste sent for recycling. The target for coolant leaks was late starting and will be carried over to 2020.
