Materials accepted

Under **condition 2.3.2 (a)** waste shall only be accepted if: *it is of a type and quantity listed in **schedule 2 tables S2.1**.*

During the inspection officers noted that some green wastes were present in some locations on the site, however as we discussed these are removed from the deposit when they are identified. Please be mindful of the materials that are accepted onto site and ensure that they conform to the list of acceptable wastes in table 2.1 of schedule 2.

Staff competency/training

The issue of your continuing competency was raised on the previous inspection in 2018. And as confirmed during the inspection has yet to be completed. Under **condition 1.1.4** *the operator shall comply with the requirements of an approved competence scheme.*

As we discussed on site this has been recorded as a **Category 3** breach of the above permit condition.

Action – as discussed you must complete your continuing competency and submit evidence of this to NRW.

Reporting and notification to Natural Resources Wales

Under **condition 4.2.2.** of the permit you are required to submit quarterly returns within one month of the end of each quarter. As we discussed on site, these have been reviewed and no issues have been identified. Using the quarterly returns we have identified that as of Q3 of 2019 a total of 19,132.4 tonnes of waste material has been deposited on site, the permit allows for a total of 45,500 tonnes.
