The compliance sample taken by NRW on 12/04/2019 returned results of 245mg/l Biological Oxygen Demand and 74mg/l Suspended Solids. Following investigations by Ceredigion County Council it was found that the sample failure was caused by a power outage.

Ceredigion County Council being unaware of the power outage until NRW samplers raised concerns about the quality of the discharge further highlights our concerns in regards to the frequency of visits to sites and lack of functioning telemetry. Tanygroes also returned a non-compliant sample result on 08/10/2018 which you were made aware of in the compliant assessment report CAR\_NRW0034055. As such, we strongly recommend you further explore what options are available for monitoring the site to prevent further permit breaches.

As a result of this offence under Regulation 38(2) of the Environmental Permitting Regulations (2016) you are being issued with a Warning.
