A routine site inspection was undertaken on Thursday 20th February 2020.

The following observations were made:

Site Drainage

Despite the inspection taking place during a period of very heavy rainfall, the site drainage system appeared to be functioning without any issues. there was no standing water and drains on site were clear from blockages.

Surface water run-off was not leaving site.

Waste Storage & Rotation

It is noted that there is a larger volume of waste now stored on site. this has increased since prior inspections. The stacks of various grades of aggregates appeared to be of very high quality and were free from contamination or non-compliant wastes.

The main stack of waste soil & stone is now beginning to grass over. It was noted on site that this material will be re-processed prior to it leaving site.

Measures should be taken to ensure waste is rotated and that no waste material is kept on site for longer than 3 years, as is required under Landfill Regulations.

Considerations for Next Inspection

It is likely that during the next inspection officers will request to see copies of various pieces of paperwork. This will include, but is not limited to: copies of Waste Transfer Notes, the Environment Management System, paperwork related to the testing/sampling of material to ensure it is free from hazardous substances.

No non-compliances were recorded during the inspection.
