Cell 5 CQA approval from NRW

Site submitted a CQA plan for NRW approval on 30th July 2019 for Cell 5a at Bryn Pica. The CQA Validation Report has now been accepted following a review by NRW Geosciences WEF 15th Oct 2019. This means that site can now commence filling cell 5 and that the site has met it's permit conditions.

We had some queries over drainage blanket extending to the top of the slope which has now been satisfactorily addressed. As have queries over the source of the under waste geotextile material, and possible damage to the cell seams when the old failed material was lifted. These three queries were satisfactorily addressed.

Site Visit 7th Nov 2019

Site also hosted a site visit to familiarise NRW permitting staff about the workings of a landfill site. During the tour, Cell 5 was visited, and seen to have 2 target pads in place with a covering of the stone drainage blanket. The site has held off from beginning the first fills of material because of the weather, but is free to commence.

Site tour findings

During the site visit, a tour revealed that the site had no excessive bird/scavenger populations. (Site employ the services of a qualified Hawker to deter bird gathering who was present on the day). There were some areas of windblown litter seen, but site also employs a litter picker who was witnessed carrying out his duties. No rodents or pests or invasive species were witnessed. No offensive odour was witnessed outside the permit boundary. No excessive noise was seen. The site has now changed the daily cover from a friable black plastic to a denser dark soil which was seen to be working well. The site has reached the top of the old cell, and is ready to start infills into Cell 5. The old cell 4 will now be covered.

NRW extends our thanks to Amgen and in particular Lee Foulkes for hosting the site visit as a valuable training opportunity for our staff.
