This Compliance Assessment Report has been produced following a review of all the monitoring data from March 2019, to date. Natural Resources Wales undertake monitoring / sampling of the permitted discharge. The decision for Natural Resources Wales to monitor / sample the discharge was taken in line with Environment Agency's Operational Instruction 74 07. All samples are analysed by Natural Resources Wales Analytical Service, which is a United Kingdom Accreditation Service (UKAS) accredited laboratory.

Permit condition 3.1.2 states that the limits given in schedule 3 of the permit shall not be exceeded. Schedule 3 has the following limits: Trichloroethene 29 ug/l, cis- 1,2 dichloroethene 42ug/l, pH 6 to 9, and, Visible oil or grease no significant trace present.
