This was a routine unannounced site inspection by Natural Resources Wales (NRW) officer Alastair Wilson (Environment Officer) and Julia Lloyd (Environment Officer).

On arrival at the site the officers introduced themselves to the licence holder (Mrs Bennett) and proceeded to carry out an inspection of the HEP scheme at the site. Mrs Bennett did not accompany the officers on the inspection.

The scheme was not abstracting during the visit, however, the monitoring screen in the generator building showed that the scheme was active, and had been generating recently, switching in and out dependent on the water level of the reservoir. Water was passing over the hands off flow notch which was unobstructed.

No compliance issues were observed during the inspection.
