The purpose of this inspection was to assess compliance with the environmental permit held by Cuddy Demolition and Dismantling (CDDL). There was no representative of CDDL on site during the inspection.

CDDL is currently in administration. Administration started on 23 July 2018. This report will be emailed to Zoe Donovan on behalf of Alistair Wardell of Grant Thornton UK LLP who are acting as administrators for Cuddy Demolition and Dismantling LTD.

At the time of inspection it was evident that the site was not operational and no waste was currently being accepted onto site.

D1 - Site Security

At the time of inspection the site gates were secured shut with blocks behind to prevent access.



C3 - Materials acceptance



At the time of inspection there was a large pile of plastics and some tyres being stored in the external yard area of site. This is non-compliant with condition 1.2.1 table 1.2 states the types of waste that can be accepted on site as 17 06 01* insulation material containing asbestos and 17 06 05 construction material containing asbestos. **CCS Score C3.**

ACTION: Please ensure that any non-compliant wastes are removed from site by the 31st October 2019.

It was not possible to gain access to the permitted area of site so no further inspection could be carried out.

Any compliance criteria not highlighted in the above summary should be considered not assessed.
