THE WORKS ARE BEING UNDERTAKEN AS PART OF A RESTORATION SCHEME TO IMPROVE THE QUALITY, QUANTITY AND CONNECTIVITY OF THE RIVERINE HABITATS PRESENT. 12. Brief Details of Flood Risk Considerations together with your Proposals for Mitigation of Flood Risk

TOPOGRAPHIC SURVEY OF THE CHANNEL AND SURROUNDING AREA HAS SHOWN THAT THE PROPOSED WORKS TO LOWERING OF THE WEIR STRUCTURES WILL DECREASE THE FREQUENCY AND DURATION OF FLOOD WATERS SPILLING TO THE MAIN CHANNEL. DURING PRE APPLICATION INVESTIGATIONS, AN "OVERFLOW SWALE" FROM THE DOWNSTREAM WEIR WAS THOUGHT TO POTENTIALLY PROVIDE FLOOD RELIEF FOR A GARDEN DOWNSTREAM. HOWEVER, FOLLOWING REVIEW OF THE TOPOGRAPHIC SURVEY CARRIED OUT THIS GARDEN AREA WOULD ALREADY BE FLOODED BEFORE RIVER LEVELS WERE ABLE TO ENTER THIS, LARGELY SILTED UP "OVERFLOW SWALE".
