- impair or interfere with amenities or other legitimate uses of the environment or use processes which could endanger human health or harm the environment.

- breach any requirements relating to [The Environmental Impact Assessment \(Agriculture\) \(Wales\) Regulations 2017](#)
- breach any other directly applicable legislation.

If you fail to comply with these requirements you may be committing an offence and enforcement action may be taken against you.
