Arrived on site at 13:00 and was meet by Adrian Taylor, Operations Director for Metro Rod and Paul Barnes, Compliance team leader for Heart of wales Property services who are working on behalf of Powys County Council.

The treatment system is a twin RBC from klargester. The rotary arms that are used as a media for the biological part of the process work of a singular axel. One of these discs has become misaligned and is jammed against the side of the inner structure. This has meant that the whole of the biological process has be heavily reduced. This has effectively turned the treatment system into a septic tank. This has been an ongoing problem and has meant that the plant has been in this condition for several months.

The outfall was inspected and found to be in good condition, however the head wall contains two discharging pipes.

**Advisory note. Signage could be put up to easily identify which discharge is relating to the treatment plant, this would reduce the risk of the plant being mis-sampled.**

The permit limits are: BOD 20mg/l and suspended solids 30 mg/l. There is no ammonia limit.

Due to the lack of biological treatment the discharge showed signs of poor quality in the form of sewage fungus staining at the sampling chamber. As the permit does not have an ammonia limit a visual inspection of the discharge suggests that it is likely to have passed the permitted limits. At the time of the visit the receiving water course was in spate, and no impact to the watercourse could be observed. In normal flow conditions It is likely that there would be significant visual impact from the discharge due to the lack of treatment from the plant.

**Action required. Investigate the root cause of the failing treatment system and fix or replace the treatment plant.**

Please submit to NRW in writing an investigation summary into the root cause of the failing system by 01/09/2019. Please include details of the work required to resolve the issue and timescale for completing the work.
