On the 4th of March 2020, I attended The Travellers Rest, Thornhill, to conduct a routine inspection of the sewage treatment system serving the site. On arrival I met the licensee, Tania Jones.

Tania told me that the treatment plant had been damaged and there was a crack in the wall of the plant. To prevent any environmental damage, the waste was being tankered away from the site every other day. Tania was unable to provide me with any waste transfer notes, as these are held centrally.

Tania also explained that a new tank was going to be installed, once planning permission had been granted.

Actions

- Condition 4.1.2: 'The operator shall keep on site all records, plans and management system required to be maintained by this permit'

- Please submit flows and loads calculations based on maximum daily loads (24 hour cycle), taking account of peak times such as bank holidays etc. - use 'Flows and Loads 4' to achieve this.

- Submit specifications of the new system.
