On 2nd January 2018, Legacy WTW experienced a power dip. This meant led to the works running treated water to waste at approximately 22.30 which continued until 02.00 (approx. 3.5 hours). The plant was running at a rate of 330m³/h, the pipe to the settlement pools has a capacity of 250m³/h and so its estimated that approx. 80m³/h would have entered the overflow pipe, discharging to the Pentrebychan Brook.

NRW officers Paul Moore and Angela Roberts liaised with Peter Evans (DVW).

If the discharge had not been allowed, there could have been a risk of insufficiently treated water entering the network. Such occurrences are covered by an emergency discharge procedure. The site attempts to reduce the flow in the event of a run to waste situation, however in this case due to the nature and timing of the incident this was not possible.

Usual procedure is to take samples if a discharge does occur, but unfortunately in this case although samples were taken, they were lost/due to new procedures (changes from Dee Valley / Hafren Dyfrdwy / Severn Trent). Remedial actions - emergency procedure to be re-sent as a reminder to all staff. The site is due to be de-commissioned by the end of March.

No reports of pollution were received d/s. Site visited the following afternoon by officers who were in the patch. No evidence of dead fish. No sample results available to indicate impact on water quality.
