This was an arranged visit scheduled for the completion date of the sale of the site from the Thomas family to Mr. Evan Jones of E.J. Metals Recycling. Jeremy Goddard (Senior Environment Officer, Natural Resources Wales) met on site with Mr. Dylan Thomas, Mrs. Margaret Thomas (Ivor Thomas & Son) and their consultant Mr. Jonathan Young, Mr. Evan Jones also joined us at the conclusion of the visit.

The weather was dry throughout the visit.

The officer was taken around the site and shown that waste had been removed from all areas including inside the buildings.

No issues were noted with the general site which was empty.

Permit Transfer

It was agreed that the permit would be transferred from Mr. Dylan Thomas to the company operated by Mr. Evan Jones and subsequent to the meeting a transfer was applied for. Unfortunately, the application that was received had to be returned as it was not duly made and at present the permit is still within the name of Mr. Dylan Thomas. The permit currently remains Mr. Thomas' responsibility even though you have sold-off the site.

I'd strongly advise that you pursue the matter with Mr. Jones to ensure the transfer is completed as at present you are still technically responsible for permit compliance on site and the payment of any permit compliance fee(s).
