Monitoring compliance Q4 (October - December) 2019

1. Breach of Permit condition 2.7.1 The limits for the level of leachate listed in Schedule 3 table S3.1 shall not be exceeded. CCS3 – Q4 2019 Leachate level exceedances reference to Schedule 5 Notifications HAF 250 and 252 versus 2 m limit.

Cell 1 (LMP1b) 9.3, 23.1 pump re-instated, 2.1 m,

Cell2 (LMP2a) replacement leachate well due February 2020,

Cell 3 (LMP3) Dip meter hung up, 2.7 m,

Cell 4 (LC4) 3.5, 2.6, 13.7 m pump off and (LMP4b) 2.9, 9.52, 13.3 m pump off, leachate level back to 2.4 m in January 2020.

3168, 3349 and 3032 m³ of leachate removed from site in October, November and December 2019 respectively (high levels due to wet weather).

Action 1: Provide a copy of the report of the leachate monitoring well camera survey undertaken in January 2020 to compare manual dips with transducer readings by 29/02/2020 (as per CAR_NRW0036206).

Action 2: Operator to provide update on the reinstatement of LMP2a and LMP4a by 29/02/2020 (as per CAR_NRW0036206).

2. Breach of Permit condition 3.1.7 The limits for landfill gas arising from the installation set out in schedule 3, tables S3.6 and S3.7 shall not be exceeded. CCS3 – Q4 2019 external monitoring boreholes' exceedances (with reference to HAF 249, 251, 253).

Methane levels ranging between 1.9 - 27.3% October, 1.9 -35.5% November and 8.3 - 52.5% December 2019 versus 1% limit.

Action 3: Operator to undertake an audit of landfill gas extraction infrastructure and coverage and report to NRW by 27/03/2020 (as per CAR_NRW0036206). This should include the location of gas wells, state of repair and sealing of gas wells (including Gazomat readings from the base of each well).
