On the 16th September 2018, a river walk was carried out on the Trefnant Brook in Cefn Mawr by NRW officers. The reason for the walk was to look at possible causes of the waterbodies failure under the water framework directive for low dissolved oxygen.

During the walk the officers noticed that there was a large amount of sewage debris caught up in the branches and tree roots along the watercourse. The largest build up of sewage debris appeared to be upstream of the bridge on Mill Lane. A possible cause for this at the time was thought to be the redundant CSO that is in the area of the build up of debris.

An investigation carried out by DCWW found that the cap on the redundant CSO was still in place and preventing any flow from entering the line. DCWW concluded that the sewage debris would have entered the watercourse from the upstream Cefn Monsanto CSO.

Checks of the watercourse were carried out in the area of the Cefn Monsanto CSO and found that the watercourse was clear upstream of this point. A visual observation of the outfall was not possible as the discharge point is within a culverted section of the Brook.

Can you please investigate the cause of sewage debris entering the Trefnant Brook from the Cefn Monsanto CSO by 17th January 2020.
