Monitoring compliance Q3 (July - September) 2019

Breach of Permit condition 2.7.1, CCS C3 - Q3 2019 Leachate Level exceedances (with reference to Schedule 6 Notifications HAF 244 and 248)

Cell 1 (LMP1b) 2.14m, 2.38m and 2.45m versus 2m limit.

Enovert report that these readings are above transducer readings, which all read between 1.0 and 1.6m throughout the period.

Cell 2 (LMP2a) Enovert submitted a CQA plan for the replacement leachate well LMP2a to NRW on 22/01/2020.

Cell 3 (LMP3) 0.67, 3.76m versus 2m limit.

Unable to manually measure in September due to dip meter hanging up, but transducer readings between 0.8m and 2m.

Cell 4 (LMP4b) 2.93m, 16.66m, 1.43m. (LC4) 1.11m, 16.85m, 1.34m versus 2m limit.

Enovert attribute high readings to perched levels, and pumps becoming clogged with "Hafod Jelly". New pump installed September. Enovert report no access point at LMP4a, being remediated.

1820m³, and 1886m³ of leachate removed from site in August and September respectively.

Action 1: As per previous CAR_NRW0035504: Enovert have reported that they plan to undertake a review of the accuracy of the transducers compared with manual readings in January 2020. Please provide an update to NRW by 29/02/2020.

Action 2: Operator to provide update on reinstatement of LMP4a by 29/02/2020.

Breach of Permit condition 3.3.5, CCS C3 - Q3 2019 various perimeter well exceedances (with reference to HAF 240, 246, 247).

Breaches of methane limit ranging between 4.6 - 39.3% versus 1% limit.

Action 3: As per previous CAR_NRW0035504: Operator to undertake an audit of landfill gas extraction infrastructure and coverage and report to NRW by 27/03/2020. This should include location of gas wells, state of repair, in particular sealing of gas wells (including Gazomat readings from the base of each well).

Breach of Permit condition 3.1.2, CCS C3 - Q2 2019 emissions to surface water (with

reference to HAF 245)

SW1a Ammoniacal N 2.9 mg/l versus 1.8mg/l limit.

Enovert report that they have reviewed Ammoniacal N concentration data since 2015 for SW1a and result seems anomalous. This review is accepted as an appropriate action for this non-compliance.
