On the 5th April 2019 at 10:55 an OSM sample was taken at Llannant Sewage Treatment Works. The sampling station number is 30471. The sampler noted that there was visible oil and grease in the sample or sample chamber and recorded this as a positive value. Visible oil & grease is a descriptive parameter listed in table S3.1 (point source emissions to water) of the permit. The limit is described as 'No significant trace present so far as is reasonably practicable'.

Please could you provide me with a report on the sample failure. The report should include:

- details of any actions you took following detection of the oil & grease,
- details of any further analysis of the sample,
- any conclusions you came to about where the oil and grease may have come from and how much was in the sample,
- any conclusions you came to about the length of time the oil and grease was present in the final effluent,
- details on how and when NRW was informed of the breach.

I will use this information to determine any breaches of the permit conditions. A second Compliance Assessment Report informing you of any breaches, recommendations and enforcement action will then be issued.

Currently I have highlighted the following conditions as being potentially breached:
