NRW officers Phil Harper and David Wilby visited Seiont Brickworks Quarry, Jones Bros. Ruthin (Civil Engineering) Co Ltd, Seiont Mill Rd, Caernarfon on the 19th February 2020 at 9:45 am. Sam Higgitt and Chris Bennett. At the time of the visit weather conditions were wet, windy and overcast.

Before entering the site, it was necessary to complete site safety induction.

At the time of the visit no waste was being imported into the Quarry and no activity was taking place.



B1 Engineering for Prevention and Control of Emissions

During the visit the final attenuation pond for waste water was observed. A brick filter was in place and in good conditions. At the time of the visit no water was being discharged from the attenuation pond. No impact on the Afon Seiont was observed.



C1 Staff Competency and Training

During the visit NRW officers were informed that Sam Higgitt Chris Bennett and have been registered onto the relevant WAMITAB course to gain competency, there is a 12 month grace period to allow new sites to obtain competency.

C2 Management System and Operating Procedures.

An Environmental Management System for the waste operation has been prepared but is embedded within other operational documents for the Bypass scheme. The relevant information should be extracted and incorporated into a stand-alone EMS document for the waste operations within the quarry linked directly to the site permit conditions

Action: Prepare a stand-alone EMS document for permitted waste operations and submit to Natural Resources Wales using the email address below by the 30th April 2020.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3 Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road.
