NRW officers Phil Harper and Dave Wilby visited Coed Ffridd Arw, Dolgellau, Gwynedd, LL40 2AB on the 18th February 2020 at 11:50 am. David Charles Williams and Gwyndaf Hughes accompanied the inspection.

The weather was dry but overcast. There was no activity on site at the time of the inspection.

The inspection was carried out shortly after a period of stormy weather, however, the site was well maintained with no litter. The concrete surfaces were all in good order and drains were visibly free from any material.

B4 Containment of Stored Materials

All waste on site was contained within the appropriate bays.

F1 Odour

No odours on site or outside of the site boundary.

Site was operational during the inspection, no excessive noise.
