NRW officers Phil Harper and Dave Wilby visited Ffridd Rasus Landfill Site, Morfa Road, Harlech, Gwynedd, LL46 2UW on the 18th February 2020 at 10:25 am. Site manager David Evans accompanied the inspection.

The weather was dry but overcast. There was no activity on site at the time of the inspection.

The inspection was carried out the day after a period of stormy weather.

At the time of the visit there was activity on site particularly within the CA site.

B4 Containment of stored materials and C4 Storage, handling, labelling and Segregation

Mixed commercial waste, cardboard waste and nappy waste were all stored inside and were stored within the appropriate bays.

Wind-blown material such as plastic waste which is stored outside, was present around and outside of the site perimeter. The inspection took place shortly after the storms Ciara and Dennis, therefore no scores have been applied on this occasion.

However, measures should be explored into retaining waste within storage bays during windy weather conditions. Ensure that regular litter picks are carried out on site.

F1 Odour

No odours on site or outside of the site boundary.

F3 Dust/fibres/particulates and litter

No dust on site, wind-blown litter around and outside the site perimeter. Ensure that regular litter picks are undertaken on site.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.

G2 Records of activity, site diary/journal/ events

A current and up to date site diary was present, please ensure that litter picks are included within the site diary.
